Can you please elaborate on the royalty free license for use	The royalty-free licence is only granted to the funder (DESNZ) and would allow them to use the foreground IP developed without paying ongoing licence fees.

There are no specific restrictions on the levels of suppliers in the auto competition. The applicant should explain how their business interacts with the auto chain, and that their solution will improve the resource efficiency of the sector.

How can be personnel costs be claimed / exposed without profit? are there personnel cost already fixed or they must be considered on the actual personnel costs based on payroll?	Employees on PAYE should be claimed at cost, i.e. payroll costs on a pro-rata basis for the duration of the project.

Any organisation is eligible to apply and costs must be within the maximum allowable costs for this competition. R&D must be at least 50% of the total project costs, including solution exploration and design. R&D can also include prototyping and field-testing the product or service
Does the technology need to be already at TRL5 or reach at least TRL 5 by the end of the project?	It needs to be at at least TRL5 at the start and TRL7 by the end

Our solution is applicable in both Chemical (recycled polymers) and construction. we are building a modular robotic system to weigh raw powder materials accurately. This will allow raw material savings and essentially reducing carbon emmision and cost savings as well as remove human operators from toxic and hazardous environment. Our system can be deployed in all sectors as you have shown, we are currently working in testing with an automotive company collaborator. Yes - if you mean two different strands (sectors) we would expect different applications for these, as the demonstrator would be in different sectors. If you mean your application covers more than one theme within a strand, then this is down to the number of demonstrators you need to do. "Thank you for the presentation. Could you please clarify whether it is mandatory for the proposed project to be royalty-free and non-profit? If so, could you elaborate on what exactly is meant by 'royalty-free' — does it refer to licensing terms or ownership rights? And in terms of 'non-profit,' does that apply to the project's operational model, or does it mean the solution cannot be commercialised at any stage?"	We actively encourage any solutions developed to pursure commercialisation post-project. Projects cannot enter into a commercial relationship for the solution being developed for the duration of the project. Non-profit relates to the cost charged by the lead applicant to the funder, these should all be at cost. Relationships between the sub-contractor and the lead applicant will be a standard commercial relationship. Royalty-free licencing is only applicable post-project if any IP has developed. This grants the funderc a royalty-free licence to foreground IP only.

You can be eligible to apply if also receiving grant funding, but the activities and deliverables must not be double funded.

The lead must be doing more work than any of the subcontractors and be best placed to own the foreground IP.
